What are « unpredictable situations »?

C*R*O*P

C: context evolution because of a disruptive event

X

R: a new risk for the project

X

O: and/or a new opportunity

X

P: with a probability level (probable vs unpredictable)

 Security crisis since 2015 with recurrent attacks by armed groups in several regions of Burkina Faso

- ✓ Massive population displacements
- **✓** Food crisis
- ✓ Limited access to essential services
- ✓ Political and institutional instability with changes in regimes and government members



Health crisis (COVID-19)

- ✓ Slowdown in economic activity
- ✓ Impact on the agricultural sector
- ✓ Worsening inequalities





How to « navigate » in unpredictable situations?

Many adaptative responses to avoid project crash!

- Be equipped with context (CROP) assesment tools
- Be ready to learn and adapt
- Be innovative
- Put managerial options on the table :

Deeper changes in agric. researchers' mindset & practices

Level 1-Changing the R&I strategy

Level 2-Changing the R&I objectives

Level 3-Changing research paradigm






How to do innovation research in these difficult contexts?

Adaptative Option A Changing project modus operandi

New way of doing research, using innovating tools

- Accessing the field without being here!
- Making use of digital technologies
 - -Satellite imagery
 - -Drones
 - -Mobile phones, call centers
- Mixed survey methodologies
- Empowering local organizations
- Local key informants



Adaptative Option B Changing the R&I strategy

Give more space for cocreation and autonomy of end-users:

- Open social innovation strategy
- Multi-actor

Constraint-based thinking

- -> taking constraints as opportunities to push forward local innovations :
- Pro-inclusive innovation
- Frugal innovation (low cost adaptation)
- Grassroot innovation (farmer-led)



Adaptative Option C Changing the R&I objectives

Take short-term action to protect innovations /ressources

Protect seed systems in conflict areas

Detect new resilience drivers and create enabling environments for innovators

Social networks as resilience factors for food systems in conflict areas



Adaptative Option D Changing ways of managing Research

Long-term, institutional learning

New paradigm for research institutions:

- From direct knowledge production, to being in support to innovation systems in countries
- Internat. research institutions supporting local research institutions
- On-demand

Adapting Research in Challenging Contexts: Key Partnerships





In such a context, it is crucial to:

- > Strengthen local partnerships with farmer organizations, cooperatives, community leaders, NGOs, and associations.
- > Collaborate closely with local authorities to ensure acceptance, ownership, and security of research activities.
- > Create North-South mirror teams, by recruiting local actors to facilitate liaison and implement certain activities (AcceSS project).
- > Co-develop context-adapted methodologies with local research centers and universities.
- Engage local companies specializing in technology and digital solutions.
- Enhance dialogue with international actors through mechanisms of political dialogue and accountability.





Recommendations for innovative research in difficult contexts

Donors:

- > Adapt funding to local realities (flexibility, real-time adjustments).
- > Support local partnerships and capacity-building for local actors.

Research Institutions:

- > Develop flexible and participatory methodologies.
- > Train local researchers for autonomous project management.

Political and Institutional Actors:

- > Facilitate coordination between institutions and local actors.
- > Support political dialogue to influence public decision-making.
